THE PREVENTION OF HARM TO CHILDREN
Risks to children using the playground on the Linney & accessing it via the Linney (from the north) as a result of increased traffic. The road is so narrow & places that cars mount the pavement & order to pass each other.

TO PREVENT PUBLIC NUISANCE
Noise levels are already high during events & would be significantly increased & would endure for longer — both to unacceptable levels. This is a residential area & the venue is totally unsuitable for the types of events envisaged.

TO PREVENT CRIME & DISORDER

Drunk youth shouting the odds walking down the Linney at midnight plus it already experienced by residents. Extending licensing hours, & increasing the number of events only exacerbates the problem.

PUBLIC SAFETY The Linney road is very narrow & places it already inadequate for 2-way traffic. - hence the existing dangerous & congested problem could only become significantly worse if there were more events at the Hughy Club.

The venue is totally unsuitable due to inadequate access.

The only solution is to refuse the license application.
