

The Linney area is a flat field, part enclosed by steep land on which the Castle is built and on which the Town Wall stands. This crates a 'bowl' which reflects and amplifies sound and is already noticeable during current events at the Rugby Club The holding of events outside of the Clubhouse, will lead to a major public nuisance and the playing of music until the early hours will ruin the peace of local residents and disturb the ability to sleep.

Equally, people drinking outside until late at night will lead to loud voices which will be easily heard by Linney residents. it is not unusual for fireworks to be used during some events and again the land-form serves to amplify the noise nuisance.

The access to the Rugby Club is via narrow roads, often where cars cannot pass each other, it is totally unsuitable for high volumes of traffic or large


