Submissions:

Claverley Parish Council: The Parish Council are in support of retaining The Plough (Function Room) as a polling place. Following notification that the venue may no longer be available, Claverley Parish Council considered the proposal to designate Claverley Village Hall as the polling place, and confirmed they were not in support due to concerns over the narrow access road and safety of electors and other road users.

Councillor Taylor (Unitary Member for Alveley and Claverley): In support of retaining The Plough (Function Room) as a polling place.

Returning Officer Representations: No changes requested for Alveley Village Hall and Quatt Village Hall as polling places. Following notification that The Plough Inn (Function Room) may no longer be available the Electoral Registration Officer is instructed to identify an accessible alternative polling place for LAB - Claverley.

Electoral Registration Officer Proposals:

The Plough (Function Room) – The existing polling place may no longer be available, and it may be necessary to identify and relocate to a replacement venue within the locality going forward. Discussions are ongoing with The Plough to resolve the issues affecting its use as a polling place. However, consideration has been given to a number of alternative venues, and further investigation is required before the Electoral Registration Officer can confirm a suitable replacement venue, if required.

The Electoral Registration Officer will continue to liaise with the local member, Councillor Taylor, to designate a suitable polling place for electors in LAB Claverley.

Financial Impact: No identified impact at the current time.

RECOMMENDATION:

It is recommended that delegated authority be given to the Electoral Registration Officer, in consultation with the local member, Councillor Taylor, to agree a replacement polling place for LAB Claverley.

Duncan Baker (Local Resident): In support of retaining Lydbury North Village Hall as a polling place.

Anonymous: In support of retaining Norbury Village Hall as a polling place.

Lily Meier (Local Resident): Concern raised over the continued use of Bishop's Castle Public Hall due to the current state of the building. It was noted that there is a risk of the building being demolished/redeveloped in the future.

Catherine Evans (Local Resident): In support of retaining Bishops Castle Public Hall as a polling place.

Returning Officer Representations: No changes requested for Lydbury North Village Hall and Norbury Village Hall as polling places. Following notification of Bishop's Castle Public Hall demolition/redevelopment, the Electoral Registration Officer is instructed to identify a temporary accessible alternative polling place for LBA Bishops Castle, LBB Colebatch, LBE Lydham and LBF Mainstone.

Electoral Registration Officer Proposals:

Bishop's Castle Public Hall – The existing polling place is due to be demolished/redeveloped, however, a timescale for works cannot be confirmed by the Town Council at this time. As a result, a temporary replacement is required to be identified and the polling place relocated until such time building works have concluded and the new site can be assessed for suitability. The Electoral Registration Officer has undertaken a site visit to the proposed polling place, and it is deemed suitable for all electors to access and considered appropriate for use as a polling place going forward.

The Electoral Registration Officer confirms that the local member, Councillor Houghton, is in support of the proposals.

Financial Impact: There would be no additional polling staff costs incurred. Venue costs would depend on the room used for the election and range from £176 (Green Room), £352 (Hall) or £576 (Sports Hall). The preferred option would be the Hall as this is the easiest room to access for electors. It should be noted that there would also be a charge of £60 to cover leisure centre staffing costs for opening and closing outside normal operational hours. These costs at the lower rate would see an increase of £142.

RECOMMENDATION:

It is recommended that SpArC Leisure Centre replace Bishop's Castle Public Hall as the designated polling place for LBA Bishops Castle, LBB Colebatch, LBE Lydham and LBF Mainstone until such time building works have concluded at Bishop's Castle Public Hall.

Electoral Registration Officer Proposals:

St James Hall – The existing polling place has seen an increase in hire costs, and it has been deemed necessary to identify other suitable premises within the polling district. The Electoral Registration Officer has undertaken a site visit to St Mary's Bluebird CE Primary School, and has confirmed the venue complies with accessibility requirements, however, due to the size of the available room, and the electorate figure being significantly less than the current threshold of 2250 electors per station, it is deemed acceptable to reduce the polling place to a single station.

The Electoral Registration Officer confirms the local members, Councillor Hurst-Knight and Councillor Lea, are in support of the proposals.

Financial Impact: There would be a reduction in staff costs of £437.63 based on current rates of pay for by-elections. There would be an expected reduction in hire charges of approximately £470.00 based on rates quoted in October 2023.

RECOMMENDATION:

(a) It is recommended that St Mary's Bluebird CE Primary School be designated as a polling place for LCE Bridgnorth (Morfe Ward) (part of).

(b) It is recommended that LCE Bridgnorth (Morfe Ward) (part of) be reduced to a single station.
