### 1. Executive Summary

The purpose of the report is to highlight the fantastic progress of the Shropshire Integrated Place Partnership (SHIPP) on delivering integrated local care in 2023/24 and to gain approval by the Health and Wellbeing Board for the SHIPP annual Strategic Plan for 2024/25.

The report describes how the transformation work across the Shropshire system is being brought together under the banner of Local Care and Neighbourhood working (facilitated by the ShIPP Local Care Neighbourhood Working Subgroup).

Recently the ICB Transformation Board has provided clarity on the work of Local Care and has agreed the scope and leadership. There are two elements, working hand in hand in order to deliver local care:

(i) the Delivery of Local Care through neighbourhood approaches (led by Shropshire and Telford and Wrekin Local authorities), and inclusive of:

- INTs/MDT approaches
- person centred care and proactive care delivery
- community navigation
- community hubs

ii) the development of Integrated Local Care pathways, led by Shropshire Community Health Trust, and inclusive of:

- end to end integrated pathway design across all providers/partners
- embedding integration of 'NHS to NHS' services as part of the 'core service offer' for INTs

This report covers the first element of Local Care (Neighbourhood) and describes the ShIPP delivery plan, inclusive the transformation work of the Local Authority and the NHS coming together through Local Care Neighbourhood working.

In 2023/24 the Shropshire Integrated Place Partnership (SHIPP) agreed the following delivery plan:

- Delivering an all-age Local Care Programme across communities in Shropshire; improving access to health, care and wellbeing services and community support. This includes:
  - Expanding the current Local Care programme and aligning services across health, care and the voluntary and community sector.
  - Using the Shropshire Integration Model to integrate services where possible, and working in partnership where integration is not possible, to deliver multidisciplinary approaches in local communities.
  - Unleashing the power of communities and the voluntary and community sector and maximizing their power to support people to maintain their independence and wellbeing at home.
  - Using public sector estate in our communities to best effect, collocating in local communities where possible (see case studies below).
  - Delivering specific elements of the Local Care programme in a collaborative and integrated way, including:
    - All age integration test and learn sites
    - Social prescribing, children and young people, families, and adults
    - Rapid response, including falls response and prevention
    - Virtual ward
    - Respiratory
    - Proactive Prevention
    - Neighbourhoods

SHIPP approved a Local Care Neighbourhood Working Group to draw together key transformation programmes and to work collaboratively to deliver the strategic plan.

# What happened in 2023/24?

- Expanded on the CYP & Families Integration to take a test and learn approach, delivering in Oswestry, North Shrewsbury, Ludlow, Bridgnorth, and Market Drayton
- Further Expansion of integrated working to develop a Community and Family Hub in Ludlow –
  PID developed for broader workstream; Sout West Primary Care Network moved into the
  Ludlow Youth Centre building in January 2024, with other services including Early Help
  joining in May 2024.
- Test and learn hub/ drop in development in **Bishops Castle**, led by Shropshire Community Health Trust Nov/ Dec 2023 learning to be used for developing monthly drop-ins
- Development of Proactive Prevention in **Bishop's Castle and Ludlow** to connect with hub approach discussions regarding including the Memory Teams, Voluntary and Community Sector offer, Social Prescribing & other personalised care/ARRS roles, Social Care etc.
- North Shrewsbury transformation of Early Help including Health Visitor Open Access
   Clinics (baby weighing) and family drop in at Sunflower House (learning to feed into hub
   approaches)
- Following success of North Shrewsbury, Open Access clinics have been commissioned across the county.
- Women's Health Hubs (WHH) integration of WHH into community and family hub planning; programme support for the development of WHH.
- Delivery of Grant fund Thriving Community and Family into 10 communities

- Highley Health and Wellbeing Centre Retrofit of the Severn Centre to house the GP
   Practice and expand the Centre to a Health and Wellbeing Centred. Recommissioned
   General Practice offer for the community. Additional activity for children and young people.
- Connected integration/ hub approaches into commissioning intentions (Wellbeing and Independence re-commissioning).
- Considering winter planning and Shropshire Council demand management wanting to support the system, focus initially on frailty, including falls. This would support Admission Avoidance and Discharge and delivered by the voluntary and community sector across Shropshire.
  - Additional winter pressure funding saw the expansion of wellbeing and independence contract with the VCSE – to provide additional support in communities.
  - Additional winter pressure funding received for falls response and is being delivered by EMED from November 2023 to March 2024.
  - Social prescribing focus on falls and CVD significant improvement in referral rates into Elevate falls service and improved joint working with the Falls Service.
- Local Care programme, Rapid Response and Virtual Ward moved into business as usual.
- Regular workshops to enhance joint working; adoption of the Prevention Framework.

Building on the work in 2023/24 a SHIPP/ HWBB workshop provided the insight and ambition for the ShIPP strategic plan for 2024/25, which was approved by ShIPP in May and is detailed below.

# SHIPP Strategic Plan for 2024/25

- Develop delegated governance with the ICB, including updating the ToR SHIPP, as well as outcome metrics and reporting on transformation programmes
- Expanding MDT approaches focussed on adults to begin to deliver Integrated Neighbourhood teams in all PCN areas; working on developing a core offer that will be available across Shropshire
- Expand CYP integrated practitioner teams as part of the Integrated Neighbourhood team model to ensure that all corners of the county and all schools are included, inclusive of:
- Trauma informed approaches, Social Prescribing and Carers (underpinned by Person Centred Approaches)
- Multi-disciplinary teams to include Social Care, Public Health Nursing, MPFT (Mental Health in Schools), voluntary and community sector and other partners
- Further develop Community and Family Hubs/ Health and Wellbeing Centres across Shropshire, including Women's Health and Wellbeing Hubs
- Primary Care Networks are supported by Multi-Disciplinary / Integrated Neighbourhood Teams and joint working where appropriate (to be articulated in the core offer)
- Through joint commissioning, establish a robust joint commissioning framework, aligned to Local Care Neighbourhood Working, for the Voluntary and Community Sector – inclusive of VCSE infrastructure and local delivery – working with outputs of the One Shropshire development work
- Development of communication and engagement tools

SHIPP will also ensure that place-based programmes include:

- Coproduction and codesign as much as is possible, involving the people who use services in transformation, service design and service improvement
- Key elements of One Shropshire and the all-age Prevention Framework and delivery plans
- Safeguarding considerations in the design and development of programmes

SHIPP will have influence and oversight of:

- Implementation of Prevention through Place Based and Transformation Programmes
- Better Care Fund Prevention, Admission Avoidance and System Flow
- System transformation work
- Carers and carers support services
- Mental Health and Substance Misuse (including RESET)

- Long term condition strategy & health pathways such as Diabetes, CVD, MSK, Phlebotomy
- Frailty and Primary Care
- Developing Diagnostic Centres
- Inspection regimes including SEND and CQC
- Housing and health integrated working including action plan and workshop outputs
- Shropshire Inequalities Strategy and Ongoing Delivery
- Healthy Weight Strategy and Action Plan and support delivery of the Whole System Approach

A key element of the Neighbourhood working group is to draw together transformation programmes through the ShIPP Local Care Neighbourhood Working subgroup. And a new ToR for this group was approved by ShIPP in May.

Details of the work and developments to deliver the ShIPP Strategic Plan for 2024/25 are highlighted below.

# Delivering the 2024/25 ShIPP Strategic Plan

# Children, Young People and Families Integration – Integrated Practitioner Teams

The work of the integrated practitioner teams has been developing since June 2022 and consists of practitioners from across public health nursing (health visiting, school nursing, Family Nurse Partnership), midwifery, substance misuse, mental health support teams in schools, Early Help, Children's Social Care, Police, Social Prescribing, Education Inclusion, Safeguarding, Housing. Developing a 'Team of Teams' approach, the practitioner team meet fortnightly face to face, in a community-based venue across Shropshire, with a weekly virtual meeting also taking place. The meetings are action focused with detailed recording of actions to support children and families. By May 2024 the approach was delivering in Oswestry, Shrewsbury, Ludlow, Bridgnorth and Market Drayton.

The approach taken to develop the team, and the site chosen, has been based on a sound methodology, using a mix of evidence base, population health need and action learning/facilitation. A series of indicators and measures are being developed of both qualitative and quantitative measures to support the evaluation of the team's impact and the community collaborative.

A structured approach to the work was first developed by the Oswestry team and consists of a Consultation Panel which was initially implemented May 2023, and was tested and reviewed before developing in the other areas of the county. This approach allows the team to measure the impact for children and families based on evidence following the actions agreed.

The work for 2024/25 is about ensuring that all areas of the county are able to access the integrated practitioner teams, and we set out the work through place-based geographies of North West, North East, Shrewsbury, South East and South West. Additionally, the work and the test and learn approach has become the cornerstone for the development of Community and Family Hubs as well as the fore runner for Integrated Neighbourhood Teams as required by Local Care and the ShIPP Strategic Plan.

# **Community and Family hubs**

As part of the Integrated Team of Teams approach, developing Community and Family Hubs as part of Local Care and the Prevention Framework, aims to address needs of children, families and adults in our communities. The Community and Family Hubs seek to further develop and deliver easier access to help and support for residents in Shropshire through expanding the existing model of place-based working. The work is part of One Shropshire, with a vision of making it easier for people to be happy, healthy and connected in their communities. These Hubs (and spokes) are intended to drive and deliver optimised services in a way that means residents can connect with multiple services in a less complex way and reduces the need for people and families to have to navigate or source support from different providers operating in different locations, which in turn should prevent escalation into complex and acute services.

As an example, in Ludlow the CYP and Families integration work (see below) is giving rise to the development of a hub approach in the Ludlow area. The Youth Centre building is an ideal location for

organisations to come together to work and to connect with the public. Key elements of this hub approach include:

- Working with the SW Primary Care Network who are occupying two rooms in the Youth Centre.
- Work with the Ludlow and Area Community Partnership (VCSE organisation) to develop an open access approach to the hub.
- Developing the Children and Family hub, working with partners, including family drop ins, stay and play, breastfeeding support and set down space for staff.
- o Developing Health Visitor Open Access Clinics, once per month.
- Operating adult and children MDTs, including Proactive Care and working together to develop the joint offer.
- Integration panel meet at the centre and partners able to meet at other times at the centre to connect with each other and the public
- Enable (help into work offer) continuing to work from the building, so that work we do can connect people to work support.
- o Ensuring the continuity of the Youth offer at the centre.
- o Develop Open Access adult health drop ins with Shropshire Community Health Trust.
- o Develop appointment base for Adult Social Care.

Following the learning thus far, Community and Family hubs are also being developed in Oswestry, Bridgnorth, Shrewsbury, Market Drayton and Whitchurch. The work including connecting with library services, where it makes sense to do so, as well as NHS partners, Enable, Carers Services and many others.

# Test and Learn Drop In to prevent Crisis interventions (Bishop's Castle):

- During a recent meeting with patients / carers of the Bishops Castle community, a local GP and both health and LA providers it became quite clear that patients and all providers were unsure of all the provisions / services available within each of the sectors and that this was a significant factor in patients reaching a crisis point.
- It was therefore agreed to trial a drop type provision at Bishops Castle where patients could attend and seek assistance. For people/ patients where their requirements are more extensive, they will be referred to the monthly MDT forum to be held at Bishops Castle for their case to be discussed and actions agreed and progressed.
- After a test and learn approach to this work, it has been agreed to develop monthly 'open access' clinics that are well publicised and available to the local community (similar to the Health Visiting Open Access Clinics).

### **Proactive Care Briefing Note**

- Proactive Care is an NHS Long Term Plan commitment that aims to provide proactive and personalised health and care to a targeted subset of individuals living with multiple longterm conditions who could benefit most and is delivered through multidisciplinary teams (MDTs) in local communities.
- o It is a model of care that is data driven, using risk stratification to identify a target cohort who are experiencing moderate to severe frailty, who experience health inequalities or who use unplanned care for routine care needs. The model utilises a population health management approach to deliver support and interventions in a coordinated way.
- The model is in development in the South West of the County. A Community Care Coordinator has been recruited and information sharing
- The Proactive Care project team are working with South West Shropshire PCN to implement the key elements of the model in a pilot approach on a small scale to understand the impact and benefits of working in this new way.
- The MDT will work from Bishops Castle Community Hospital, beginning in January 2024 with involvement from system partners and providers including SCHT, Shropshire Council, MPFT, Primary Care and the voluntary and community sector. A full evaluation of the pilot will take place in March to take forward the learnings and determine the system benefits.

Additionally, the Neighbourhood work will endeavour to learn from and connect with other transformation programmes currently developing in Shropshire. This includes the Community Mental Health Transformation and Adult Services Transformation, both described below.

### CMH Transformation

Working alongside the Local Care Neighbourhood Group is the transformation of Community Mental Health Services, to ensure that the work is aligning and we are making best use of resources. Lessons learned from the CMHT have been shared with the Local Care Neighbourhood Group and more work is needed to align the MDT approaches.

### **Adult Services Transformation**

Shropshire Council's Adult Services are also transforming services which will align with Neighbourhood working developments. Some information about the transformation programmes is outlined below and more work will be needed to embed in the neighbourhood working arrangements.

- Community reablement offer soft roll out of a community reablement pilot in the Central area, running alongside hospital discharge reablement service. Offering reablement assessment period with START for new people coming into ASC front door where there is reablement potential identified early, so not just for individuals who have come out of hospital. Aligned with AT, TECH and VCS and OT. So a holistic assessment during an agreed period of time, with focus on optimising the individual utilising all services to ensure they are as independent as possible. This is with the aim of early intervention, prevention the need for funded and ongoing services.
- Front Door service wide transformation piece to look at managing the demand at the front door and enhancing the front door offer. Online assessment portals, directing people to appropriate services that can support them. Upskilling staff at FPOC to ask the right questions at the right time, link in closer with Shropshire Local and LTL & family hubs, increasing the offer at the hubs, so people of Shropshire can have advice and guidance from multiple agencies at one place (housing, health, ASC, VCS).
- Transport ASC transformation piece to look at current transport offer, this includes increasing travel training offer, training day centre staff to do this with as many day centre attendees as possible, increasing independence and ability to access community, reducing reliance on paid transport and utilising public transport in a safe way. Linking in with Shropshire Transport Consortium about what they can offer, expanding their voluntary community offer to more places.

### Conclusion

There is a huge amount of work developing in this space. The system needs to pay particular attention to bringing the work together, ensuring that we don't duplicate and that we are making best use of resources.

# Governance

ShIPP subgroup ToR agreed at May ShIPP meeting.

ShIPP subgroup agreed a move to geographical groups to take forward the work in the South West, South East, Shrewsbury, North West and North East areas. Subgroup will move to monthly.

Shropshire Council governance mirrors ShIPP governance for now, to be reviewed in 6 months.

# Neighbourhood Working and Community & Family Hubs Key Points -

South West – Ludlow - Contextual safeguarding meeting held during the integration consultation panel, to discuss concerns raised by a GP surgery and JSNA. Sessions will be developed further by EC & JR alongside the Integrated practitioner teams. Hub at the Youth Centre continues to develop.
 Joint Integration comms group established to develop cohesive approach. Updates via existing comms channels as a soft comms launch updating on new integration locations and the new referral form. HV open access clinic update distributed including location. Public Health One Shropshire comms distributed. EH website updated to reflect integration changes and webpages now live.

# North West Oswestry

Health Visiting Drop In Clinics –will confirm delivery date when issue with CAT is resolved and the family hub location is confirmed, hopefully the HV's will be delivering1st & 3<sup>rd</sup> Monday of the month.
