

REPRESENTATIONS PROCEDURE NOTES

- A representation can be made against an application for a premises to carry on a licensable activity within the 28 day consultation period. Representations can also be made against applications to make variations to an existing licence.
- Representations may be made by:
- Responsible authorities
- Other persons
- To make a representation you much complete and send this form to <u>licensing@shropshire.gov.uk. Representations may also be submitted by post to:</u> Licensing Team, Business & Consumer Protection Service, Shirehall, Abbey Foregate, Shrewsbury, SY2 6ND.

<u>PLEASE NOTE:</u> The representation form must be received by the Licensing Team before the end of the consultation period stated on the site notice, newspaper notice and the Council's website, or it will not be accepted. Posted representations not received within a consultation period due to the postal system will be treated as late and not accepted.

- Where a representation is accepted as relevant, the Council will share the representation in its entirety with the applicant and their agent. This is to allow them an opportunity to consider the issues raised in the representation and discuss possible ways to mitigate the objector's concerns with them directly.
- Only in exceptional circumstances will personal details be redacted from representations. This will be when the Council considers that there is a genuine risk of intimidation / violence to the persons making representation. Persons making representations who consider this to be a risk should make it clear on their representation and they will be contacted to discuss further.
- At the end of the consultation period, if any representations remain, the name and address of persons making representations will be published on the report to the LicensingSub Committee, which will be publicly available.

THE PREVENTION OF CRIME AND DISORDER

There has to be an increased likelihood of anti social and disorderly conduct in the areas surrounding these premises, particularly at the end of the evening. This could well overspill in to the surrounding residential areas.

PUBLIC SAFETY

There will be increased foot traffic in the surrounding areas. Most of these areas have no pavements and are accessible to motor vehicles, causing risk of pedestrians being struck by cars.

Also there is a fire risk from discarded cigarettes being discarded over the wall and into the meadow which adjoins Blackfriars Crescent and is tinder dry in the summer months.

THE PREVENTION OF PUBLIC NUISANCE

This is the main thrust of my objection. The application requests permission for live and recorded music indoors and outdoors within normal licensing hours and extended hours over bank holidays. The rear of the Parade is in the vicinity of predominantly residential accommodation, approximately 100

The rear of the Parade is in the vicinity of predominantly residential accommodation, approximately 100 apartments I believe.

It overlooks Blackfriars where I live and sound from the Parade carries clearly to my apartment as was the occasion one day last summer when there was a pop-up event in the Parade car park. The noise was as loud and clear as if I was actually present at the event. I have a recording of this available if required. I also believe the Old Meadow Estate across the river will be detrimentally affected by this proposal.

If approved this proposal will cause considerable disruption and distress to myself and my family and I urge you to deny this application and any other variation thereof.

Failure to do so may well force us to move as we have only recently moved here and greatly appreciate the peace and solitude of Blackfriars.
