

REPRESENTATIONS PROCEDURE NOTES

- A representation can be made against an application for a premises to carry on a licensable activity within the 28 day consultation period. Representations can also be made against applications to make variations to an existing licence.
- Representations may be made by:
 - Responsible authorities
 - Other persons
- To make a representation you much complete and send this form to licensing@shropshire.gov.uk. Representations may also be submitted by post to: Licensing Team, Business & Consumer Protection Service, Shirehall, Abbey Foregate, Shrewsbury, SY2 6ND.

<u>PLEASE NOTE:</u> The representation form must be received by the Licensing Team before the end of the consultation period stated on the site notice, newspaper notice and the Council's website, or it will not be accepted. Posted representations not received within a consultation period due to the postal system will be treated as late and not accepted.

- Where a representation is accepted as relevant, the Council will share the
 representation in its entirety with the applicant and their agent. This is to allow them
 an opportunity to consider the issues raised in the representation and discuss possible
 ways to mitigate the objector's concerns with them directly.
- Only in exceptional circumstances will personal details be redacted from representations.
 This will be when the Council considers that there is a genuine risk of intimidation /
 violence to the persons making representation. Persons making representations who
 consider this to be a risk should make it clear on their representation and they will be
 contacted to discuss further.
- At the end of the consultation period, if any representations remain, the name and address
 of persons making representations will be published on the report to the LicensingSub
 Committee, which will be publicly available.

THE PREVENTION OF CRIME AND DISORDER

Possible intrusion on private property, our residents private terrace. There is already a very serious existing drug problem/dealing around the back of St. Mary's Church, facing the side entrance of The Parade. This could easily become more aggrevated by an easy accessible late licensed premises. The drug dealing could move to behind The Parade/The Court, they could use the toilets in The Parade. We do not feel safe knowing that drug dealers could simply walk around the back of the premises at any time. The Court are private dwellings directly over the Parade and our safety will be compromised with a late licensed premises.

PUBLIC SAFETY

More traffic and parking around St. Mary's Square, potentially obstructing emergency vehicle access, making an already congested area, worse.

Food waste, smells and light will attract vermin from river, which is detrimental to an apartment complex.

\ \ \ \ \ \ \ \ \ \ \ \ \ \ \ \ \ \ \	Windsor Place very easily. Opportunities for peace and quiet are already limited, it will become even worse. We both in our 40s go to bed very early, rarely after 2130. One of us has a chronic illness where good sleep is crucial to our well being, the other is in the Army and needs their sleep too. We have no balcony or garden, our only outdoor area is the terrace at the end of the car park area. We will loose our already limited privacy if this license is granted. This is an elevated area where no amount of cleolaced furniture or greenery will block us or our view. We do not wish to see or hear people out eating, drinking, music playing, ights etc while we are trying to relax in our only outdoor space. We enjoy the noise of nature out the back of the property. The restaurant will not just block out nature sounds but drive birds etc away from property completely.
•	THE PROTECTION OF CHILDREN FROM HARM
	Local drug dealing already a problem, as discussed earlier. This is no place for children to be around.

All representations in their entirety, including your name, address and contact details will be disclosed to the applicant for the premises licence and their agent.
•	If limited or withheld personal details are redacted from representations, where notice of a hearing is given to an applicant, the licensing authority is required under the Licensing Act 2003 (Hearings) Regulations 2005 to provide the applicant with copies of the relevant representations that have been made.
