1 PREVENTION OF PUBLIC NUISANCE.

I feel that the introduction of a licensed bar into this quiet, residential corner of a town that is already well catered for in the main thoroughfares of the centre, would be detrimental to the peace and quiet enjoyed by the local, often older, residents.

The application 'flies in the face' of the vision set out by Mr. Bob Freeman and Andrew Arrol, the original developer and architect to convert a derelict former hospital into a smart desirable building in keeping with Shrewsbury's image of an elegant county town.

The use of the limited toilet facilities in The Parade , given the potential number of customers is wholly inadequate.

2 PREVENTION OF CRIME AND DISORDER

While I understand the wine / tapas bar is planned to be confined within the units, it will be difficult/ impossible to prevent customers from spilling out onto surrounding areas.

I am sure that the security of the neighbouring shop units will be of concern to those traders. The increased footfall will also impact the residents of the

apartments above and in the adjoining buildings . The threat of noise pollution will certainly increase.

2 local examples are The Yorkshire House Pub and The Do and oil Bar on Castle Street , both of these are difficult for pedestrians to pass without stepping on to the road causing problems for passing traffic and the inevitable safety issues.
