Every Member is required to register and disclose certain interests **and those of their Partner** where they are aware of the existence of such interests.

- (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you or your partner has a beneficial interest exceeds one hundredth of the total issued share capital of that class.
