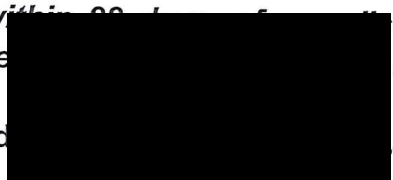
NOTES ON SENSITIVE INTERESTS
