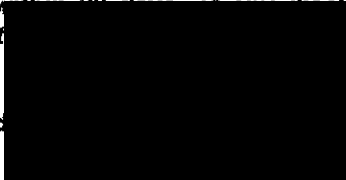
**NOTES ON SENSITIVE INTERESTS**
