Corporate tenancies  Any tenancy where (to your knowledge)— (a) the landlord is the Council; and (b) the tenant is a body in which you or your partner has a beneficial interest.	NONE
Securities  Any beneficial interest in securities <sup>6</sup> of a body where—  (a) that body (to your knowledge) has a place of business or land in the area of the Council; and
