| <b>Sponsorship</b><br>Any payment or provision of any other financial benefit (other than from the Council) made or provided within the relevant period <sup>3</sup> in respect of any expenses incurred by you in carrying out your duties as a member, or towards your election expenses.<br>This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992. | NONE  |
| <b>Contracts</b><br>Any contract which is made between you or your partner (or a body in which you or your partner has a beneficial interest <sup>4</sup> ) and the Council —<br>(a) under which goods or services are to be provided or works are to be executed; and<br>(b) which has not been fully discharged.  | NONE  |

<sup>1</sup> "member" means a member of the authority and includes a co-opted member;

<sup>2</sup> Partner includes your spouse, civil partner or person with whom you are living as if they were your spouse or civil partner

<sup>3</sup> "relevant period" means the period of 12 months ending with the day on which you give a notification of its existence

<sup>4</sup> "body in which the relevant person has a beneficial interest" means a firm in which you or your partner is a partner or a body corporate of which you or your partner is a director, or in the securities of which you or your partner has a beneficial interest; and "director" includes a member of the committee of management of an industrial and provident society

| <b>Securities</b><br>Any beneficial interest in securities <sup>6</sup> of a body where—<br>(a) that body (to your knowledge) has a place of business or land in the area of the Council ; and<br>(b) either—<br>(i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body; or<br>(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you or your partner has a beneficial interest exceeds one hundredth of the total issued share capital of that class. | NONE   |

### NOTES ON SENSITIVE INTERESTS
