This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.</p> | |
| <p><u>Contracts</u> Any contract which is made between you or your partner (or a body in which you or your partner has a beneficial interest⁴) and the Council — (a) under which goods or services are to be provided or works are to be executed; and (b) which has not been fully discharged.</p> | |

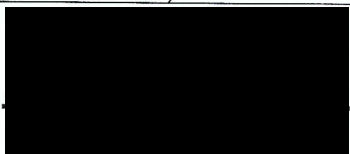
