Every Member is required to register and disclose certain interests and those of their Partner where they are aware of the existence of such interests.

<p><u>Employment, office, trade, profession or vocation</u></p> <p>Any employment, office, trade, profession or vocation carried on for profit or gain by you or your partner</p>

<p><u>Sponsorship</u></p> <p>Any payment or provision of any other financial benefit (other than from the Council) made or provided within the relevant period in respect of any expenses incurred by you in carrying out your duties as a member, or towards your election expenses.</p> <p>This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.</p>

Contracts

Any contract which is made between you or your partner (or a body in which you or your partner has a beneficial interest) and the Council —

- (a) under which goods or services are to be provided or works are to be executed; and
- (b) which has not been fully discharged.

Land

Any beneficial interest in land which is within the area of the Council.

(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you or your partner has a beneficial interest exceeds one hundredth of the total issued share capital of that class.
