<u>Corporate tenancies</u>	Any tenancy where (to your knowledge)— (a) the landlord is the Council , and (b) the tenant is a body in which you or your partner has a beneficial interest	NONE
<u>Securities</u>	Any beneficial interest in securities ⁶ of a body where— (a) that body (to your knowledge) has a place of business or land in the area of the Council , and (b) either— (i) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body, or (ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you or your partner has a beneficial interest exceeds one hundredth of the total issued share capital of that class	NONE
