#### REGISTRATION AND DISCLOSURE OF PECUNIARY INTERESTS

As a Member<sup>1</sup> of Shawbury Parish Council (the Council) I am required to register certain interests (known as "disclosable pecuniary interests") of my own and of my partner<sup>2</sup>. These interests are set out in the table below.

When I am present at a meeting of the Council and I have a disclosable pecuniary interest (which includes your own interest and that of your partner) in any matter being considered which is entered in the Council's register of interests, I do not need to disclose it to the meeting, but I will withdraw from the meeting room when the matter is being discussed and will not participate, or participate further, in any discussion of, or any vote taken on, the matter at the meeting.

If my disclosable pecuniary interest (which includes your own interest and that of your partner) is not entered in the Council's register of interests, I will disclose its existence and, unless it is a sensitive interest<sup>3</sup>, its nature, to the meeting and will notify the Monitoring Officer of the interest within 28 days of the meeting. I will withdraw from the meeting room when the matter is being discussed and will not participate, or participate further, in any discussion of, or any vote taken on, the matter at the meeting.
