**Every Member** is required to register and disclose certain interests **and those of their Partner** where they are aware of the existence of such interests.

(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you or your partner has a beneficial interest exceeds one hundredth of the total issued share capital of that class.

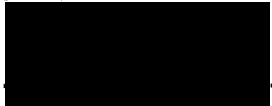
**NOTES ON SENSITIVE INTERESTS**
