### NOTICE OF PUBLIC PATH ORDER AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER

# THE SHROPSHIRE COUNCIL (FOOTPATH 13 (PART), PARISH OF WELSHAMPTON & LYNEAL) PUBLIC PATH DIVERSION ORDER 2018

The above named order made on 25<sup>th</sup> October 2018 by the Shropshire Council ("the Council") under section 119 of the Highways Act 1980, will **divert** 

the full width of that part of Footpath 13, Welshampton & Lyneal, from point A on the order map (SJ 4319 3497), running in a general north-north-westerly direction for approximately 25 metres through the gardens of three barn conversions. It then curves around in a general north westerly, westerly and then south westerly direction for approximately 27 metres around the property Oak Farm Barn before continuing in a general south westerly direction for approximately 38 metres. From there it runs in a general north westerly direction along a track for approximately 76 metres to meet the continuation of footpath 13 at point B on the order Map (SJ 4305 3502); a total distance of approximately 166 metres; **onto a line** from a pedestrian gate at point B on the order map (SJ 4305 3502), running in a general east-north-easterly direction on a natural surface for approximately 153 metres to pass through a pedestrian gate (SJ 4321 3503) giving access to a surfaced track which the route follows in a general east-north-easterly direction for approximately 79 metres to meet the county road at point C on the order Map (SJ 4329 3505); a total distance of approximately 232 metres with a width of 2 metres throughout.
