

**NOTICE OF PUBLIC PATH ORDER AND DEFINITIVE MAP
AND STATEMENT MODIFICATION ORDER**

**HIGHWAYS ACT 1980
WILDLIFE AND COUNTRYSIDE ACT 1981**

**THE SHROPSHIRE COUNCIL (BRIDLEWAY 48A (PART),
PARISH OF CULMINGTON) PUBLIC PATH DIVERSION ORDER 2020**

The above named order made on 16th January 2020 by the Shropshire Council (“the Council”) under section 119 of the Highways Act 1980, will **divert**

the full width of that part of Bridleway 48A Culmington, from point A on the order map (SO 4757 8453), running in a general north westerly direction between hedges and then continues in the same direction across the garden associated with 15 The Knotches to point B on the order map (SO 4743 8467); a total distance of approximately 202 metres; **onto a line** to be created from point A on the order map (SO 4757 8453), running in a general north westerly direction along a stone surfaced track for approximately 168 metres to point C on the order map (SO 4745 8464) where the route leaves the track via a bridleway gate and turns to follow a general northerly direction between a fence and hedge for approximately 40 metres to point B on the order map (SO 4743 8467) where it rejoins the remainder of Bridleway 48A; a total distance of approximately 208 metres with a width of 3 metres throughout.

A copy of the order and the order map and an explanatory statement have been placed and may be seen free of charge at the Council offices at The Shirehall, Abbey Foregate, Shrewsbury during normal office hours or via the Council’s website at <https://shropshire.gov.uk/outdoor-partnerships/countryside-access-and-public-rights-of-way/current-public-path-orders/>. Copies of the order and map may be bought from the Council, at the above address at a cost of £6.50.

Any representations about or objections to the order may be sent in writing to the Mapping and Enforcement Manager, Shropshire Outdoor Partnerships, The Shirehall, Abbey Foregate, Shrewsbury, SY2 6ND, or by email to outdoor.recreation@shropshire.gov.uk, not later than 14th February 2020. Please state the grounds on which they are made.

If no such representations or objections are duly made, or if any so made are withdrawn, the Council may confirm the order as an unopposed order. If the order is sent to the Secretary of State for the Environment, Food and Rural Affairs for confirmation any representations and objections which have not been withdrawn will be sent with the order.
