The applicant requests the surveying authority to add the route to the definitive map as a bridleway. It is arguable that the evidence suggests that carriageway rights exist over the route as it appears on maps sold to the public between 1827 and 1941 and was excluded from valuation under the Tithes and the Finance Act 1910. However due to the current construction of the law and the proposed extinguishment of unrecorded rights in 2026, the application will be made for bridleway status with an acknowledgement that the surveying authority should make an order for Restricted Byway / Byway Open to All Traffic status if they consider that merited.
