

# 1. Summary of Findings

Case SH/195/017 was included in the research scope by the Discovering Lost Ways Project as the route is shown on the Ordnance Survey Explorer Mapping as an "Other Route with Public Access". The route is not currently recorded on the Definitive Map and Statement, but is part-adopted by Shropshire County Council and recorded on the List of Streets (U1953/10).

From the documents examined it is possible to establish that the case file route has existed as a physical feature since at least 1847 as shown on the Tithe Survey map. The Finance Act maps show the route uncoloured and excluded from hereditaments and depicted as consisting of two parallel solid black lines. This suggests that the route was considered to be a public highway at the time of the Finance Act Survey, but does not in itself provide evidence about the class of rights that existed over it. The deposited railway records describe the route as 'public' in this case a "public highway" and the owner of the route is described as a public body. The Ordnance survey records also support the physical presence of the route.

The Ordnance Survey 1" New Series Map demonstrates evidence for the route. The route is shown on the map and is described in the key as '3<sup>rd</sup> class metalled road'. For the purpose of the Discovering Lost Ways Project research it has been agreed that the showing of routes as 1<sup>st</sup>, 2<sup>nd</sup> or 3<sup>rd</sup> class metalled roads on OS 1" New Series maps will be taken as evidence of the existence of public vehicular rights. The case file route is shown in this way and it is felt therefore that a public vehicular right of way existed over the route at that time.

The evidence found meets the standards set out in Section 53 of the Wildlife & Countryside Act, 1981 that a public right of way subsists or is reasonably alleged to subsist and therefore been categorised as "Strong", supporting the making of a definitive map modification order application to add the route to the definitive map.


# 2. Description of Route

The route begins on U1953/10 at the junction with Ossage Lane (C2066/10 and C2066/20) at coordinate SJ4885 3360 (point A on the case file route map). The route continues along U1953/10 in a north easterly direction to where this it terminates at coordinate SJ4911 3413 (point B on the case file route map).


The route has a length of 643 metres.



The route is observed to terminate at a junction with another road to the west of the letter "A" of "Alders" on the map.


3. Ordnance Survey Surveyors Drawings, BL 326, entitled "PARTS OF Shropshire Cheshire and Flintshire", dated 1829, demonstrates evidence for all of route T000694. The route is observed to commence at a point north west of that labelled "Village Bridge" on the map. The route is shown un-named and uncoloured on the Ordnance Surveyor's Drawings and is depicted as consisting of two parallel solid black lines. The route is observed to terminate at a point north east of the commencement point where it meets another route.



4. Ordnance Survey 1" Old Series, SHR Ordnance Survey Old Series 1": 1mile, entitled "Folder 1 1833 - 1835", dated 1833 - 1835, demonstrates evidence for all of route T000694. The route is observed to commence at a junction with another route to the north west of the letter "O" of "Ossage Bridge" on the map. The route is shown on the map and is depicted as consisting of two parallel solid black lines. The route is observed to terminate at a junction with another route to the west of "Alders" on the map.



It is shown but is unnumbered and not within a numbered parcel and is depicted as consisting of two parallel solid black lines (in-filled). The route is observed to terminate at the north eastern corner of land parcel "52" on the map.



6. Tithe Apportionment, TNA IR29/29/347, entitled "APPORTIONMENT of the RENT-CHARGE in lieu of TITHES in the Township of Whixall in the Parish of Prees in the County of Salop.", dated 1847, covers the area but demonstrates no evidence for case SH/195/017.

The route is observed to commence to the north west of the "A" of the label "PARISH OF PREES". This shows the route specifically numbered on the plan in this case "78" and is depicted as consisting of two parallel solid black lines. This shows the route outside the Limits of Deviation. The route is observed to terminate at "78" marked on the map.



8. Railway Section, SHR DP/404, entitled "ELLESMERE, RUABON, AND SHREWSBURY RAILWAY. Plans and Sections", dated 1861-62, covers the area but demonstrates no evidence for case SH/195/017.



officer, "Thomas Woodvine and John Dawson surveyors...", with the implied responsibility for maintenance of public highways.



This route is observed to commence at a point that is on the southern edge of the documents extent at the eastern boundary of OS land parcel "1263". The route is shown uncoloured and excluded from hereditaments. This route is observed to terminate at the north west corner of OS land parcel "1219".





18. Estate Map, SHR D3651/E/1/3/3/26, entitled "WHIXALL ESTATE. AS ALLOTTED FOR SALE.", demonstrates evidence for all of route T000694. The route is observed to commence at its junction with a main route at the south west corner of field parcel 64 ("Lot XVII"). The route is shown but is unnumbered and not within a numbered parcel and is depicted as consisting of two parallel solid black lines. The route is observed to terminate at a point that is north of the commencement point.



# 7. Interpretation of Evidence from Individual Records

## Evidence of status:

This evidence concerns the existence of a public right of way. The ARU's research establishes whether a way is described as "public" or "private" and whether public rights can be inferred from other information provided within the documentary source. Evidence of status is categorised as follows:

## Evidence of class:

## **Evidence of physical characteristics:**

This evidence relates to the physical appearance of the case file route as recorded in documentary sources, even if these sources do not themselves contain evidence of the route's status or class.

Items of evidence relating to physical characteristics are recorded using a series of 'physical appearance' codes.

The following items of evidence were found to relate to the physical characteristics of the case file route:

## Evidence of width:

This evidence relates to the legal width of the case file route – for example, legally defined widths (e.g. in Inclosure Awards).

There is no evidence to support a legal width for the route.

## 8. Overall Evaluation of Evidence

The evaluation of the evidence has been carried out in accordance with the Discovering Lost Ways Project's series of Research Standards (for specific references see Appendix A below).

## Findings from the main documentary sources:

### 1. Tithe Survey Records

The Tithe Survey Map demonstrates evidence for the route. The route is shown un-numbered and not within a numbered parcel. The route is depicted as consisting of two parallel solid black lines (in-filled).

## 2. Finance Act Survey Records

The Finance Act Maps of 1909/1910 show evidence for the route. It is depicted as consisting of two parallel solid black lines and is shown uncoloured and excluded from hereditaments. This suggests that the route was considered to be a public highway at the time of the Finance Act survey, but does not in itself provide evidence about the class of rights that existed over it.

### 3. Deposited Railway Records

The Deposited Railway Plan demonstrates evidence for the route. The route is shown specifically numbered on the plan and is depicted as consisting of two parallel solid black lines. The route is shown outside the limits of deviation. The book of reference describes the route as 'Public' in this case a "public highway" and the owner of the route is described as a public body.

## 4. Estate Records

The route is also shown on the Estate map as consisting of two parallel solid black lines. The route is show un-numbered and not within a numbered parcel.

### 5. Non-Ordnance Survey Commercial Mapping

The Non-Ordnance Survey Map demonstrates evidence for the route. The route is shown on the map and depicted as or described as "Turnpike Road" in the Key or legend. The route is depicted on the map as consisting of one bold and one fine solid parallel black line.

#### 6. Ordnance Survey Documents

#### a. The Ordnance Survey Surveyors Drawings

The Ordnance Survey Surveyor's Drawing shows evidence for the route. It is shown as uncoloured and un-named and is depicted as consisting of two parallel solid black lines.

#### b. The Ordnance Survey 1" Old Series

The Ordnance Survey 1" Old Series demonstrates evidence for the route. The route is shown on the map and is depicted as consisting of two parallel solid black lines.

## c. The Ordnance Survey 1:2500 1st Edition

The Ordnance Survey 25" 1<sup>st</sup> Edition demonstrates evidence for the route on two sheets. The route is shown on the both maps and is depicted as consisting of two parallel dashed black lines (in-filled), and is specifically numbered on both maps.

### d. The Ordnance Survey 1:2500 2<sup>nd</sup> Edition

The Ordnance Survey 25" 2<sup>nd</sup> Edition demonstrates evidence for the route on two sheets. The route is shown on both maps and is depicted as consisting of two parallel solid black lines. The route is shown but is un-named on both.

#### e. The Ordnance Survey 1" New Series

The Ordnance Survey 1" New Series Map demonstrates evidence for the route. The route is shown on the map as consisting of two solid or pecked fine parallel black lines and is described in the key as '3<sup>rd</sup> Class Metalled Road'. For the purpose of the Discovering Lost Ways Project research it has been agreed that the showing of routes as 1st, 2nd or 3rd class metalled roads on OS 1" New Series maps will be taken as evidence of the existence of public vehicular rights. It is felt therefore that a public vehicular right of way existed over the route at the time of the survey.

#### Alignment of the case file route:

From the analysis of the Finance Act Map and Modern Ordnance Survey Maps, the route does not appear to have changed alignment.

#### No evidence of width:

There is no evidence to support a legal width for the route.

#### **Contradictory evidence:**

No contradictory evidence was found for the route

#### Outcome of the evaluation:

Case SH/195/017 was included in the research scope by the Discovering Lost Ways Project as the route is shown on the Ordnance Survey Explorer Mapping as an "Other Route with Public Access". The route is not currently recorded on the Definitive Map and Statement, but is part-adopted by Shropshire County Council and recorded on the List of Streets (U1953/10).

From the documents examined it is possible to establish that the case file route has existed as a physical feature since at least 1827 as shown on the Tithe Survey map. The Finance Act maps show the route uncoloured and excluded from hereditaments and depicted as consisting of two parallel solid black lines. This suggests that the route was considered to be a public highway at the time of the Finance Act Survey, but does not in itself provide evidence about the class of rights that existed over it. The deposited railway records describe the route as 'public' in this case a "public highway" and the owner of the route is described as a public body. The Ordnance survey records also support the physical presence of the route.

The Ordnance Survey 1" New Series Map demonstrates evidence for the route. The route is shown on the map and is described in the key as '3<sup>rd</sup> class metalled road'. For the purpose of the Discovering Lost Ways Project research it has been agreed that the showing of routes as 1<sup>st</sup>, 2<sup>nd</sup> or 3<sup>rd</sup> class metalled roads on OS 1" New Series maps will be taken as evidence of the existence of public vehicular rights. The case file route is shown in this way and it is felt therefore that a public vehicular right of way existed over the route at that time.

The evidence found meets the standards set out in Section 53 of the Wildlife & Countryside Act, 1981 that a public right of way subsists or is reasonably alleged to subsist and therefore been categorised as "Strong", supporting the making of a definitive map modification order application to add the route to the definitive map.
