**THE SHROPSHIRE COUNCIL (BRIDLEWAY 10 (PART), PARISH OF MORVILLE)  
PUBLIC PATH DIVERSION ORDER 2021**

This Order is made by the Shropshire Council ("the Council") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the Council that in the interests of the landowner of the land crossed by the bridleway described in paragraph 1 of this order it is expedient that the line of the way should be diverted.

This Order is also made under section 53A (2) of the Wildlife Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Shropshire definitive map and statement require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this Order) of a highway shown or required to be shown in the map and statement.

**BY THIS ORDER:**

1. The public right of way over the land situated at Orchard House and shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up on the date of confirmation of this order and thereupon the Shropshire definitive map shall be modified by deleting from it that public right of way.

2. Notwithstanding paragraph 1 of this Order statutory undertakers shall have the following rights over the land referred to in paragraph 1 above, namely:

Where immediately before the date on which the bridleway is diverted there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of carrying on their undertaking, the undertakers shall continue to have the same right in respect of the apparatus as they then had.

3. There shall on the date of confirmation of this Order be a public bridleway over the land situated at Orchard House described in Part 2 of the Schedule and shown by a bold broken line on the map contained in this Order and thereupon the Shropshire definitive map shall be modified by adding that path to it.

3A. The Shropshire definitive statement shall be modified as described in Part 4 of the Schedule to this order.

4. The rights conferred on the public under this Order shall be subject to the limitations and conditions set out in Part 3 of the Schedule.

## **SCHEDULE**

### **PART I**

#### **Description of site of existing path or way**

Leaving the County Road at Point A on the Order Map (SO 6818 9197), through a gate then running in a general north westerly direction through a further 4 gates on a grass surface to Point B on the Order Map (SO 6755 9211). A total distance of approximately 675 metres.

### **PART 2**

#### **Description of site of new path or way**

Leaving the County Road through a gate at Point C on the Order Map (SO 6791 9243) running in a general south westerly direction on a grass surface to a further gate then continuing in a general south westerly direction on a grass surface to re-join the Definitive Line of BW 10 at Point B on the Order Map (SO 6755 9211). A total distance of approximately 496 metres with an unfenced width of 3 metres throughout.

### **PART 3**

#### **Limitations and conditions**

**Gate at Grid Reference SO 6791 9243 to BS 5709**  
**Gate at Grid Reference SO 6775 9227 to BS 5709**

### **PART 4**

#### **Modification of Definitive Statement**

Leaving the County Road through a gate at Point C on the Order Map (SO 6791 9243) running in a general south westerly direction on a grass surface to a further gate then continuing in a general south westerly direction on a grass surface to re-join the Definitive Line of BW 10 at Point B on the Order Map (SO 6755 9211). A total distance of approximately 496 metres with an unfenced width of 3 metres throughout.
