

THE SHROPSHIRE COUNCIL (A5 NORTH TO A5 EAST CLASSIFIED ROAD) (SIDE ROADS AND OTHER WORKS) ORDER 2021

The Shropshire Council make the following order in exercise of its powers under sections 6, 14 and 125 of the Highways Act 1980 and all other powers enabling them in that behalf: –

1. The Council is authorised in relation to the classified road at A5 Mile End Roundabout in the County of Shropshire to carry out the following works:
 - (a) improve the length of highway named in the Schedule to this Order and shown on the Site Plan by cross hatching;
 - (b) stop up the length of highway described in the Schedule and shown on the Site Plan by zebra hatching;
 - (c) stop up the private means of access to premises described in the Schedule and shown on the Site Plan by a solid black band; and
 - (d) provide a new means of access to premises along the route shown on the Site Plan by thin black diagonal hatching.
2. The new access is given a reference number on the Site Plan, which is placed in the said Schedule.
3. Where a new access is to be provided in connection with the stopping up of a length of private means of access described in the Schedule, its reference number is placed in the Schedule opposite the description of that length.
4. The Site Plan shows the works indicated in the Schedule and the route of the classified road in relation to those works.
5. Where immediately before a length of highway is stopped up in pursuance of this Order there is under, in, on, over, along or across that highway any apparatus of statutory undertakers or any telecommunications code system operator then, subject to section 21 of the Highways Act 1980, those undertakers, or that operator, as the case may be, shall have the same rights as respects that apparatus as they had immediately before the stopping up took place.
6. In this Order:
 - (a) distances are measured along the route of the relevant highway;
 - (b) “the classified road” means the new highways to be constructed as part of the A5 Mile End Roundabout upgrade: (i) A length of new highway to be constructed from a point 377 metres north of the Mile End Roundabout in a south easterly direction for a distance of 712 metres to the A5 East Road, including a new roundabout to be constructed to the north east of the existing Mile End Roundabout (given the reference letters B and A on the Site Plan) ; and (ii) A length of new highway to be constructed from the existing Mile End Roundabout north eastwards to the new roundabout proposed to be constructed as part of new highway (i) above, a distance of 69 metres in length (given the reference letters C and D on the Site Plan), and which is a proposed highway which is a classified road in accordance with section 12 of the Highways Act 1980.
 - (c) “the Council” — means the Shropshire Council;
 - (d) “improvement” in relation to a highway includes raising, lowering or otherwise altering that highway, and “improved” shall be construed accordingly;
 - (e) “new access” means a means of access to premises authorised by this Order to be provided; and
 - (f) “the Site Plan” — means the Site Plan numbered 70046089-SK-002 marked “THE SHROPSHIRE COUNCIL (A5 NORTH TO A5 EAST CLASSIFIED ROAD) (SIDE ROADS AND OTHER WORKS) ORDER 2021”.
