

Email RE: Consultation on draft Cleobury Mortimer Neighbourhood Development Plan - extension to end date

As you will be aware we have been representing NHS interests during the Shropshire Local Plan Process.

As part of this it was agreed at the recent Stage 1 Public Examination Hearings that the NHS would co-ordinate its input into the proposed infrastructure delivery arrangements. It is intended that this should, on an ongoing basis, identify where improvements to health facilities of all types will be required and where new development might provide support to the provision of that infrastructure, whether through CIL and/or S106. Assuming this mechanism starts and operates as planned on an ongoing basis, then issues that might arise at locations across the county should get picked up and this should filter through to Neighbourhood Development Plans, as appropriate.

At this stage, therefore, we have no further observations on the draft Cleobury Mortimer Neighbourhood Development Plan.
