In respect of particular paragraphs of the Local Plan:

#### 6.4 - 6.8

- It's really important that Greenbelt around Albrighton is kept clear of houses
- Any developers that try and build on Green Belt should not be allowed to do so
- New housing in Albrighton should be built on Millfields, ALB017 & ALB021 (Wain Estates and next to it)
- Any new large buildings for employment / jobs should be at RAF Cosford and in smaller ad-hoc buildings
- Developments in Albrighton must be phased so that the village does not become overwhelmed, lose its character and community feel
- Any areas outside these sites must not be released from Greenbelt now or in the future especially not the Boningale Homes proposed Albrighton South sites P36A and P36B

Large shopping areas are easily accessed from Albrighton and its environs, the village itself and the small independent shops and businesses it hosts would be decimated by the introduction of larger complexes.
