Ludford Parish has 3 large new housing development in addition to many historic and graded listed buildings. Ludford Parish Council has worked closely with the planning authority to ensure that there is a healthy mix of special requirement housing and plenty of employment which is local to the housing sites. All of the developments offer DDA compliant properties. At Rock Green there is an established traveller site with 3 plots, access to toilet facilities etc.

On the Foldgate development there at 5 new bungalows, as well as affordable housing provision. ELV charging facilities have also been installed. Ludford has upgraded its street lighting to energy efficient bulbs.

There is a new Sainsburys supermarket, offering accessible grocery shopping together with an ongoing development by Marks and Spencer which will be a food hall.

The Eco Park and the Lower Barnes estate offer quality work space and employment for the Parish.

The Park and Ride for Ludford and neighboring Ludlow is situated in Ludford and Ludford Parish Council are liaising with local Councillors to install a new bus shelter near to the Sainsburys Supermarket serving Rock Green to promote sustainable travel in the area.
