I have studied the Shropshire local plan and fully support it for the following reasons:

Housing and employment

- Shropshire council have already decided to build an additional 500 houses and therefore any plans to develop on green fields/ green belt should be rejected.
- Recently built and planned house building in Albrighton already meets new housing needs.
- The steady growth proposed by Shropshire council for the development of areas ALB017 and ALB021 is appropriate as opposed to rapid development.
- Shropshire council are against building on green belt, which I fully agree with. We should be
 protecting farmland to safeguard future food production needs, particularly at a time of
 worldwide unrest and uncertainty regarding the supply of imported food products.
 Green belt and open countryside is conducive to healthy living and both mental and physical
 well-being. It also provides important and essential natural habitats.
- Shropshire council recognise that Albrighton is not a suitable location for large employment buildings, especially on its green belt land. Developments such as these should be built close to large populations, preferably on brown field sites, thereby minimising the need for the workforce to travel.
- It is also recognised that Albrighton does not need a secondary school as this would cause traffic chaos and require children to be bussed or driven in. Also large buildings such as supermarkets and drive-throughs would destroy the tranquillity and feel of the village and have a significant negative impact on existing shops and businesses. It would additionally have a major environmental impact both throughout the build and after completion.
- Once green belt land is unnecessarily built on it is lost forever and we will have failed future generations to satisfy the greed of developers.

I have studied the Shropshire local plan and fully support it for the following reasons:

Green belt

- Shropshire council has identified suitable areas within the county (Tasley, Shrewsbury and
 the former Ironbridge power station) for development to meet the Black Country housing
 need so under no circumstances should green belt land (outside of this plan) be allowed to
 be developed. Within Albrighton land has been safeguarded for housing after 2038; this is in
 my opinion an acceptable plan for future housing needs.
- I am pleased that Shropshire Council recognises the need to preserve the green belt around Albrighton. Access to green belt is a major asset for the health and well being of the local residents, particularly regarding physical and mental health. It provides a natural habitat for wildlife, with the ecologically and sustainably farmed agricultural land within our green belt and conservation areas supporting species on the 'red list' such as skylarks and yellow hammers. Such productive farmland should be protected at all costs especially with the potential for a future food crisis in the UK; once this land is lost to development it can never be retrieved.
- For all the reasons I have identified in my response, I feel strongly that Albrighton is NOT the
 right place to accommodate development in order to fulfil the Black Country housing
 requirements and I therefore fully support the Shropshire Local Plan.
