It would be unfortunate if the unique character of Albrighton were to be compromised by "over the top" development outside the Local Plan.


- 4.14 4.21: it is good that Shropshire Council agrees that new housing is built in line with this Plan and that no development be allowed if not included. Any Black Country housing should be at Tasley, Shrewsbury and former Ironbridge Power Station.
- 5.24 5.27: I agree that land should be safeguarded from development and kept clear for houses to be built after 2038 ... any proposals to develop the land before 2038 should be resisted.
- 6.4 6.8: Well thought-out and 6.6 in particular is reassuring. I understand that there are new housing developments in Albrighton (e.g. Millfields). It is important to residents of Albrighton that the village is not overwhelmed by excessive new developments so that the essential character of the village is compromised. It is right to respect the wishes of the residents.
- 6.13: It is good to see that the Plan recognises that there are better places in Shropshire for unmet Black Country needs, and not in Albrighton.
