I understand the need for additional housing to some extent but feel that, as in table (8.3) the houses in ALB017 and ALB021 should be built steadily over a 10 year period. Following this burst of house building at Millfields and next to it at Wan Estates, there should be less development in the village at the end of the period up to 2038.

The medical practice has an excellent reputation and Outstanding CQC report and we work extremely hard to maintain this. We have obtained planning permission to extend the clinical areas on our current site in Show Lane in order to accommodate the expanded patient population.
