The Shropshire Local Plan's approach to accommodating unmet housing needs from the Black Country (paragraphs 4.15-4.19) seems well-considered. Identifying four specific sites with additional sustainability assessments (paragraph 4.17) ensures balanced development that meets both community needs and environmental responsibility. This

targeted strategy aligns perfectly with the Local Plan's overall spatial strategy for sustainable growth (paragraph 4.18). Most importantly it requires NO new land to be released from the greenbelt.

Shropshire must remain a rural county and keep our beautiful village's unique characteristics for ours and future generations to continue to enjoy.
