Q4. Please detail your comments on the specified document(s). Please be as precise as possible.

We are objecting to the Size and Site of the Employment Allocation for Shifnal. During our long occupation and indeed recently, since the extraordinary growth of housing in the town we have seen no evidence to justify the larger site and certainly not expanding beyond Upton Lane. The incoming residents are primarily white-collar workers who commute to the West Midlands using the Town's excellent Transport services. In past housing planning applications, the M54 and extensive Railway links has been seen as a major justification for their approval.

I am Managing Director of a Company that has owned Premises and Land at the Lamledge Lane Industrial Estate, Shifnal, since 1986. We have 28 skilled employees who work with us in the Creative Arts Industry, and together we have gained a substantial Worldwide reputation for our products.

In May 2012 I was approached by Shropshire Councillor, the late, Stuart West who invited me to a meeting with Helen Howie, Liam Cowden and Peter Wilson, all officers of Shropshire Council. The purpose of this meeting was to gain my support for the safeguarding of Lamledge Lane Industrial Estate as an Employment Zone and the expansion of the site, in the area now known as SHFO18a/P14, to help Shropshire's Economic Growth Plans. To this end, I was asked to provide written evidence specifying various sections of the forthcoming SAMDEV MD11 and MD3 proposals, this was then substantially edited by a SC Council Officer.

We duly applied for Planning permission to expand our premises this was granted in March 2013. At this time, we were given Undertakings by the same SC Officer that the Industrial Estate would receive the necessary investment, in time and resources, to validate our considerable financial outlay.









In late 2017 as the MD of one of the largest employers in the Town I was invited to a meeting with Liam Cowden and Shropshire Councillor Kevin Turley at which I was shown plans for Shifnal Enterprise Park. Please see Attachment B

This seemed the logical answer to the Town's needs, to address ours and other growing local Businesses future growth. In my experience Larger Companies are catered for by Telford and Wrekin Council that have an abundance of available Land and the necessary resources for their greater needs.

Dear Robert

My apologies, I am preparing for my principal SAMDev Consultation meeting at Craven Arms this Thursday and the strategy itself absorbs a lot of time to push forward and to establish the necessary contacts between those parties required to support its implementation. I appreciate the need to address the issue of potentially safeguarding Lamledge Lane Industrial Estate and to set out a few outline proposals to present to the other owners of the Estate.

As I recall, in relation to the SAMDev, I suggested that you support at least one of our Preferred Policy Directions namely MD11 – Existing Employment Areas & Established Employment Sites but you might also consider supporting Policy Direction MD3 – Sites for Employment Uses.

In relation to the timing of your response. The SAMDev consultation is due to end on 20 July 2012 and you say, time is slipping away. However, the SAMDev process is intended to be a continuing discussion and should you submit your comments beyond the 20th they would still be accepted. I have suffered delays to the Consultation for Craven Arms for unforeseen reasons the consultation will be extended until 10 August. If you were within this extended period and especially if you noted that you were working me on the Lamledge Lane Industrial Estate then your comments would still be accepted.

In relation to the content of your response. A simple letter setting our your intention to relocate your business from Ironbridge to Shifnal your support for the SAMDev Policy Directions in MD3 and MD11 would suffice. You should explain that you own land / premises at Lamledge Lane Industrial Estate and believe the estate to be important due to its strategic location but the estate needs investment in its fabric and management. You should say - you believe the improvements at Lamledge Lane would be achieved more readily if Policy Direction MD11 were to be introduced and the Council were to identify existing employment Areas to be safeguarded and that Lamledge Lane IE should be included as a safeguarded site. You might also say that, you also support Policy Direction MD3 because it proposes to bring land forward in accordance with Policy MD11 and you believe that safeguarded existing employment areas for business uses will make an important contribution to the future prosperity of the Shropshire economy.

I am writing in support of the Shropshire County Councils SAMDev

Preferred Policy Directions MD11 and MD3 and suggest that these policies should be used to safeguard land and premises at Lamledge Lane, Shifnal for employment use as discussed with Shropshire Council officers. As stated at our meeting on May 28th 2012.

We wish to propose these are the plans for the future development of our Lamledge Lane pPremises and land to -

We propose to reinstate the UK production of our Figurines and Decorative Sculpture products that are currently made offshore. A key part of our decision making will rely on the intentions of Shropshire Council to safeguard the status of Lamledge Lane Industrial Estate as a site for employment use. The proud heritage of the site is actually contemporary with that of the nearby Ironbridge World Heritage site, which is acknowledged as the Birth place of Industry. In fact the original name of the site was The Coalport Works, confirming its place in the history of the Industrial Revolution. At one time in the late 20th century over 600 people were employed in Edge's Chain Works on this site, obviously contributing significantly to the wealth of the Town.

Robert Harrop Designs have owned the site since 1990 and in fact in 1998 employed 25 full time and 120 part time workers in Shifnal. Along with the majority of our industry we were forced to outsource manufacture to remain competitive. The circumstances have now changed back in favour of UK production prompting us to review the use of our Lamledge Lane Factory.

The Company has an international reputation for Originality and Quality and as such is involved with prestigious partners and projects in the Film and Publishing industry, as shown in our Company Literature. At our leased premises in Jackfield we have an Archive Gallery of over 1700 individual models which have been created over the past 25 years. Our work is appreciated by over 3,000 collectors who visit us from all over the world, this is obviously of benefit to the local Hotels, restaurants etc. It is our intention to build a Visitors Centre on our freehold land in Shifnal, bringing similar commercial opportunities to the town.

To summarise, we believe that through Shropshire Councils support of SAMdev MD11 we can bring the following to Shifnal:

- 1) Adult Employment
- Apprentice Training
- Tourist Revenue.
- 4) Town Pride

As mentioned, we are wish to working with Shropshire Council, namely Mr Liam Cowden

to safeguard and promote this important piece of Eemployment site land in Shifnal to be retained as an employment location in Shifnal and wish to promote investment in the fabric of the estate to improve the attractiveness and viability of this important employment area close to the strategic road and rail corridor along the M54.
