I strongly believe that agricultural land is important to secure our future food production sustainability and employment locally for farmers and their businesses and therefore believe that agricultural land should be protected from development. (12.4)

I am committed to supporting our local farming community. The green belt sustains farming businesses, which are vital to our sustainable living, local economy, and rural character.

I feel threatened by a developer in my area who has proposed to build 800 hundred houses, School etc because they feel that the Local Plan is incorrect. This was reflected in the minutes of a meeting presented by Boningale Homes at a Public meeting. A good plan that you have suggested will stop this. (4.14-4.21)

Your plan has already suggested suitable settlements for growth.(12.4)

Walking through the green spaces is one of our greatest joys, offering natural beauty on the door step of a bill allowing short and longer walks to all categories of people. These are important for our health and well being. (8.7-8.8)

The conservation area borders the green belt. If developed it would merge with Albrighton removing its unique identity and rural charm(6.4-6.8)

I feel if our farms and green spaces are replaced with multiple developments without a plan, all of the above ie lifestyle, character, sustainability and supporting the farming community and would change. For that I support the allocation of the land that you have carefully considered that would be more suitable as a plan. (12.1- 12.4)

I am also happy that Shropshire Council have decided to allocate a further 500 houses by 2038. We are contributing in a considered and sustainable way to the housing growth required by our country as a whole. In principal, I don't object to housing growth. (Ref 7.63 - 7.64)

I feel that life in Albrighton is balanced at the moment with green spaces and gradual growth.Supporting this plan is essential for preserving our agricultural integrity, and would ensure that our green belt remains protected for future generations
