I am a resident of Albrighton and have lived in the village for the last years, having chosen the rural location after living in a busy city environment. My home, situated on the edge of Albrighton village and surrounded by Greenbelt farmland that my family and many residents in Albrighton regularly walk through and enjoy. I feel privileged to call Albrighton my home, in part due to its beautiful landscape but also the friendly village community of which I take an active role. My husband and I have spent a great deal of time, effort and money on the maintenance and up-keep of the historical home we live in and have worked conscientiously to ensure it is in-keeping with the surrounding environment and in-line with planning requirements etc. Although our home is surrounded by Greenbelt it is in reasonable walking distance to amenities on the High Street, a local school, doctors surgery, leisure facilities and the train station.

I have given close attention to Shropshire Councils' work on the draft Shropshire Local Plan over the last few years and am grateful to be given this opportunity to submit a response during its final consultation phase. Having read and understood the draft Local Plan document I can confirm that I support it in many areas as referenced in this document. It is a well-considered, positive document and the persons responsible for its development have ensured that the residents of Shropshire have had the chance to engage with its development (12.1-12.3)

My main area for support is related to Greenbelt and future housing developments, all fully addressed by the draft Local Plan. Greenbelt is so important now in the UK and potentially under threat should there be changes to planning laws. I feel that the draft Local Plan gives robust but reasonable protection of the Greenbelt around Albrighton (Paragraphs 8.7-8.8 and Appendix 3; Updated Stage 3 Site Assessment), while supporting sustainable housing developments and employment opportunities by highlighting specified areas across Shropshire and specifically where I live in Albrighton (7.63 and 7.64).

It is vital to give protection to Greenbelt in Albrighton because it will prevent urban sprawl - its fundamental purpose for being established many years ago and still relevant today. Greenbelt will maintain important farming areas, sustaining UK food production and minimising financial impacts from global factors. It gives Albrighton its desirable natural surrounding landscape, adding to the character of the village, and provides habitats for essential biodiversity as well as accessibility and visibility of open green spaces – both of which are essential to positive mental health. The Local Plan has carefully considered the areas suitable for development and has given consideration to non-Greenbelt land as a priority, which is correct and in accordance with current planning law and regulations (12.3, 7.63 and 7.64).

I am further supportive of the Local Plan because it clearly defines the allocated areas for current and future housing development in Albrighton (Table 8.10and Table 12.4). There is careful consideration given for the most appropriate sites for current and future housing and employment needs throughout Shropshire and in Albrighton and these areas are identified and named and limitations are set-out explaining where sites should not be developed (4.14-4.21, 7.63, 7.64 and table 8.3, 16.64). The draft Local Plan, when adopted, will ensure housing needs are met in Shropshire, and importantly for me in Albrighton, until 2038 and beyond while maintaining control of the locations and consideration of densities (6.4-6.8). I believe that the Local Plan is consistent with National Policy and has considered my needs as a resident of Albrighton now and into the future. It is also encouraging to see joint engagement across nearby counties to ensure its success within the wider West Midlands community (6.13). I trust it will be approved to provide future security within Shropshire.
