Throughout this time I have been an active member of the community, being a member of various village organisations, including treasurer of 2. Working with the Albrighton & District Civic Society for the village I and one other was involved in the sourcing and planting of 4 large planters of flowers to make the High Street attractive to all for all 4 seasons of the year for many years.

When we first moved here most of the major development had already taken place. Since then there has been infill and minor developments giving stable growth, This approach maintained the character and integrity of our village, ensuring it remained a peaceful and pleasant place to live.

However, in the last three years I have noticed a significant increase in major developments. This rapid expansion threatens to overwhelm our village, bringing with it a risk of crowding and losing the very essence of what makes this place special.

I wholeheartedly support the Local Plan as it aims to protect our village from overdevelopment by preserving the green belt and ensuring thoughtful, controlled growth, we can maintain the unique charm and community spirit that has made this village a wonderful place to live for over half a century.

It clearly defines the allocated areas for current and future housing which will ensure housing needs are met in Shropshire until 2038.

## Shropshire Local Plan - Updated Green Belt Topic Paper

#### 4.14 - 4.21

- Shropshire Council has put of lot of work into its plan for housing in Shropshire and it is right that any new housing should be built in line with this plan.
- If it is not in the Local Plan then developers should not be allowed to build on it.
- I agree that it is right that the Black Country housing needs should be in Tasley (BRD030), Shrewsbury (SHR060, SHR158 & SHR161) and the former Ironbridge Power Station.

#### 5.24 - 5.27

- I agree that there should be land safeguarded from development so that it is kept clear for houses to be built after 2038.
- If Developers try and get permission to build on that land before 2038 then this should not be allowed.

#### 6.4 - 6.8

- It's really important that Greenbelt around Albrighton is kept clear of houses.
- Any developers that try and build on Green Belt should be thrown out.
- New housing in Albrighton should be built on Millfields, ALB017 & ALB021 (Wain Estates and next to it).
