# Introduction

Part 1 of Shropshire Council's new parking strategy – which considers issues relating to provision of, and payment for, on-street and off-street parking - was approved in January 2018 following a 12-week public consultation in 2017. We are now carrying out a further consultation on a small number of additional proposals.

These proposals are focussed on four towns, and – in most cases – on specific groups within each of these towns. We are therefore particularly inviting responses from these groups, though we welcome views from anyone with an interest in these matters.

Please read and consider any proposals that relate to you, or in which you have an interest.

**Note**: From 9 to 30 May 2018 we are also consulting formally on the Traffic Regulation Orders (TROs) that will allow Part 1 of the parking strategy to be implemented.

# **BRIDGNORTH**

# **Location: Low Town**

#### Existing position/issue

The current on-street Traffic Regulation Order (TRO) permits the proprietor or manager of a hotel, guest house, bed & breakfast, self-catering or holiday let establishment to apply for visitor permits, valid for one day, which will allow their guests to park on specified streets within existing on-street residents' parking schemes.

#### **Proposal**

That the provision of visitor permits is removed and replaced with a provision to allow the proprietor or manager of a hotel, guest house, bed & breakfast, self-catering or holiday let establishment to apply for season tickets for use by their guests in any Shropshire Council car parks listed as Bands 4, 5 and 6 in accordance with the season ticket tariffs, proposed in part 1 of the new parking strategy (recommendation xiii).

# Reason/s

- To give priority to, and improve availability of limited on-street provision to, permanent residents and their visitors who have registered and purchased on-street residents' parking permits.
- To ensure a consistent approach across the county.
- To ensure appropriate provision is made available in accordance with the principles of the parking hierarchy (in the spirit of the new strategy).

#### **Potential impact**

- Additional availability for residents' on-street parking.
- Season tickets are not as flexible as visitor permits, would cost more and there would be a minimum purchase of one month.
- Potential increase in distance of parking from premises.
- Proprietors can administer online.

Location: Mereside on-street
<b>Existing position/issue:</b> The parking strategy proposal for 50% concessions on Sunday, bank and public holidays does not promote the parking hierarchy.

recommendation xvi of the part 1 parking strategy proposals. Tariff rates on Sunday, bank and public holidays will therefore be £1.00 per hour, rather than 50p per hour

# Location: On-street Pay & Display and residents' parking (red zone)

**Existing position/issue:** The Traffic Regulation Order (TRO) currently provides for permit concessions to market traders.

Proposal: Removal of this concession.

## Reason/s

- To prevent market trader usage shift from Castle Street car park to on-street, and hence address car park/town centre congestion issues and promote use of alternative car parks more appropriate to vehicle type.
- To promote availability of space for pay and display parking and resident permit holders.
- Concession should not be more favourable than that available to residents.

- Increase in availability for residents/visitors.
- Less town centre congestion.
- Increase in parking congestion in outlying car parks.
- Not as convenient for market traders to return to vehicles.

# **Location: Off-street car parks**

**Existing position/issue:** The Traffic Regulation Order (TRO) currently provides for permit concessions allowing for the proprietor or manager of a hotel, guest house, self-catering or holiday let establishment to purchase season tickets in named off-street car parks.

**Proposal:** Provision removed and replaced with a provision to allow the proprietor or manager of a hotel, guest house, bed and breakfast, self-catering or holiday let establishment to apply for season tickets for use by their guests in any Shropshire Council car parks listed as Bands 4, 5 and 6, as recommended in accordance with the season ticket tariffs within part 1 of the new parking strategy (recommendation xiii).

#### Reason/s

- To ensure a consistent approach across the county.
- To ensure appropriate provision is made available in accordance with the principles of the parking hierarchy (in the spirit of the new strategy).
- During the public consultation the need to retain or provide new provision for guests of hotel, guest house, bed and breakfast, self-catering or holiday lets was raised.

- Season tickets are not as flexible as visitor permits, would cost more and there would be a minimum purchase of one month.
- Potential increase in distance of parking from premises.
- Proprietors administer online.

SHREWSBURY
Location: Raven Meadows multi storey car park

**Existing position/issue:** Opening hours at Raven Meadows are currently 8am to 6pm. On Sundays, bank and public holidays a flat rate tariff for up to 10 hours stay applies. It is proposed that 24-hour opening is introduced permitting parking for stays longer than 10 hours. If as currently proposed the 10 hour cap on the flat rate is retained, the standard hourly tariff for periods of stay beyond 10 hours will apply. There are also proposed caps on the standard tariff for any periods of stay over eight hours and periods of stay over three hours incurred after 6pm.

**Proposal:** Amend recommendation xvi of the part 1 strategy proposals to remove the proposed 10 hour cap and allow unlimited periods of parking on Sunday, bank and public holidays for the flat rate of £1.50 per day.
